

EQUIPMENT RENTAL AGREEMENT

This Equipment Rental Agreement ("Agreement") is made between Hawai'i Kine Camping ("Company") and the customer ("Renter") identified at the time of booking.

By booking a camping package or submitting payment, the Renter agrees to the terms below:

1. Rental Items

The Company agrees to provide the Renter with camping equipment and supplies selected in the rental package. Equipment may include, but is not limited to:

- Tents, canopies, air mattresses, cots, lights, tables, chairs, cooking supplies, and accessories.
 - A detailed equipment checklist can be provided at the time of set-up upon request at reservation.

2. Rental Term

- The rental term begins on the confirmed check-in date and ends on the check-out date specified in the booking.
 - Early checkouts do not qualify for a partial refund.

3. Delivery, Set-Up & Pick-Up

- Equipment will be delivered, set up, and broken down by Company staff at the Renter's designated campsite.
 - Renter must have a valid Hawai'i County Camping Permit prior to booking services.
 - Renter agrees not to move, tamper with, or relocate equipment from the original set-up area.

4. Deposit and Payment

- A **\$300 refundable deposit** is required at the time of booking.
 - The deposit will be refunded within 10 business days after check-out, pending equipment inspection.
 - Renter is financially responsible for any lost, stolen, damaged, or excessively dirty equipment. A full itemized replacement/repair list (“Schedule A”) is available upon request.

5. Renter’s Responsibilities

Renter agrees to:

- Use equipment only for its intended purpose.
 - Keep all items safe, secure, and in good condition.
 - Avoid smoking, open flames, or illegal substances in or near the equipment.
 - Ensure children are supervised at all times.
 - Notify the Company immediately of any issues or damages.

6. Damage, Loss, or Theft

- Renter will be charged for any equipment that is lost, stolen, damaged, or returned in unusable condition, beyond normal wear and tear.
 - Costs will be deducted from the deposit. If damages exceed the deposit amount, Renter agrees to pay the balance due within 7 days of notice.

7. Cancellations & Refunds

8. Limitation of Liability

- The Company is not liable for any injuries, accidents, property damage, weather conditions, or third-party issues that occur during the rental period.
- Renter assumes full responsibility for the safety and conduct of all guests during the rental.

9. Release of Liability and Assumption of Risk

By renting and using the equipment, Renter acknowledges the risks involved in outdoor camping and releases Hawai'i Kine Camping and its affiliates from all liability related to injury, death, or property loss.

10. Governing Law

This Agreement shall be governed by and interpreted under the laws of the State of Hawai'i.

11. Entire Agreement

This Agreement constitutes the entire agreement between the parties. Any changes must be made in writing and agreed upon by both parties.
